

In this month's report, we bring to light the alarming instances of persecution faced by the Ahmadiyya community in Pakistan. It is disheartening to note the continued disregard for the fundamental rights and freedoms of Ahmadis, despite their unwavering commitment to their faith and to the prosperity of Pakistan.

The report highlights several concerning incidents. Firstly, two Ahmadis are unjustly targeted in a police case, perpetuating discrimination and fear. Moreover, thirteen Ahmadis are unjustly charged under anti-Ahmadiyya laws, exacerbating the marginalization of the community. These individuals face baseless accusations simply because their mosque shares similarities with other mosques.

The situation worsens as three Ahmadis face additional blasphemy charges, increasing their vulnerability. Moreover, a brutal mob attack has targeted an Ahmadiyya mosque, resulting in significant damage. Other mosques also face ongoing threats.

Ahmadis, as loyal citizens of Pakistan, strive for peaceful coexistence and the nation's prosperity. We call upon authorities to ensure justice and human rights, allowing all citizens to practice their faith without fear. By embracing diversity and safeguarding the rights of all, Pakistan can cultivate a harmonious and prosperous society.

POLICE CASE AGAINST TWO AHMADIS IN RAJANPUR

Basti Allah Dad. **District** Rajanpur; May 12, 2023:

A false police case was registered against six Ahmadi seniors allegedly for preaching Ahmadiyyat in a local Ahmadiyya school under sections 295-B. 295-A, 298-A, 298-B, 298-C and 506 on July 23, 2020 at Police Station Rajanpur City.



Three of the accused were arrested and later acquitted from court but could not return to their hometown due to hostile situation. Five Ahmadis out of six accused had to leave the country to live cused relatives to flee abroad, in the police station in some peace.

Thereafter, the police registered another police case and arrested two Ahmadis Mr. Muhammad on May 13, 2023.

THIRTEEN AHMADIS BOOKED **UNDER ANTI-AHMADIYYA PPC 298-B**

Chak 565, District Faisalabad; May 19, 2023:

The police booked 13 Ahmadis under anti-Ahmadiyya law PPC 298-B, with FIR no. 204 at Police in the area and organized hostile activities have Station Bachiana, objecting to the design, minaret and niche of the Ahmadiyya place of worship.

There has been long-standing sectarian strife increased in recent times. The SHO referred the matter to the DCO Faisalabad and bound the parties in writing that until there is an order from the higher officials, neither party will take any action.

On May 22, the lawyers' gang attempted to enter the courtroom but they were not allowed, so they chanted anti-Ahmadi and other slogans outside the courtroom to pressurize the judge. The judge heard the case and granted post arrest bail to Syed Tariq, the next day.

The honourable judge recorded in his Order, "As for as merits of the case were considered, learned Additional Prosecutor General was of the view that the applicant deserved no mercy and was guilty of an offence under sections 298-B and 298-C PPC." The APG represented the provincial government that is led these days by PPP under the chairmanship of Mr Bilawal Bhutto Zardari.

A police case was registered against Syed Tariq 30 years ago, under PPCs 295-A, 298-C for saying Islamic greetings, in police station Shahdadpur, District Sanghar. This case was still pending. The opponents approached the civil judge/ judicial magistrate Shahdadpur for this pending case who issued production orders against Syed Tariq.

Syed Ali Ahmad Tarig was expected to be released on May 27, 2023 in the latest case, but due to this new production order in the case of October 20, 1992, his release has stalled. The septuagenarian gentleman is still in prison, simply for being Syed and wishing Salaam. Zindah Baad, the Islamic Republic!

BLASPHEMY SECTION ADDED AGAINST THREE AHMADIS, ON DEMAND

Chak TDA/185, District Bhakkar; May 07, 2023:

Three Ahmadis, Mr. Zubair Ahmad, Mr. Tahir Ahmad and Mr. Mubasher Ahmad, were booked under PPCs 341, 34, 298, 337V, 506, at Police Station

Mr. Zubair Ahmed has a mobile shop. The plaintiff had a financial dispute with him. He filed an application that he had a financial dispute with the said three persons; this led to a a fistfight. He alleged that during the fight, the persons named in the case grabbed his beard and dragged him, thereby the Prophet's Sunnah was insulted, and since the accused are Qadianis, a blasphemy case

should be registered against them. The SHO registered a case under section 298, apart from other sections. He took the accused into custody, and remanded them. After the registration of the case, Sadar Bhakkar with FIR no. 479 and were arrested. clerics, political leaders and some lawyers organized a press conference and campaigned on social media, demanding the administration to add a higher blasphemy clause. Otherwise, they threatened to protest. Given the hostile situation and hostile reaction from the lawyers, these accused were not presented in the court for bail on May 8, 2023. They will be presented in court after the situation improves somewhat, the police said.

AHMADIYYA MOSQUE IN SINDH **TARGETED IN VICIOUS ATTACK**

Dholan Abad, Mirpur Khas; May 4, 2023:

A group of assailants attacked the Ahmadiyya mosque in district Mirpur Khas, causing extensive damage to its structure. This desecration of the mosque marks the ninth such incident in the first five months of this year alone and the sixth in the province of Sindh. This is an alarmingly high number for a small community, with an average of almost two mosques being vandalized every month.

According to reports, a mob of approximately 150 people arrived at the mosque at around 9 a.m. and forcibly entered the premises by placing a ladder against the building. The assailants then proceeded to bring down the mosque's four minarets and attempted to damage the niche. The mosque is located in the center of Mirpur Khas City and has shops in its basement.

Despite their efforts, the assailants were unable to break down the mosque's main gate. However, they set fire to the belongings of the Ahmadis, including their clothes and other possessions.


This mosque was constructed in the 1980s and is situated near Fazl e Umar Hospital, which was founded by Dr. Abdul Mannan Siddiqui, a renowned, people friendly Ahmadi doctor who was martyred in 2008 after a hateful TV program against Ahmadis.

Following his death, many Ahmadi families residing in the neighborhood of the mosque were forced to relocate to various other areas of the city.

Although Ahmadis were few in number in this area, the offering of prayers had recently resumed after being suspended for more than a year. After the mob had destroyed the minarets of the mosque, the police arrived and dispersed them.

The spokesperson of the Ahmadiyya Commu-





nity in Pakistan tweeted; "Continuous attacks on Ahmadiyya worship places are a gross violation of human rights. Today's attack on the Ahmadiyya place of worship in Dholan Abad, Mirpur Khas by a mob of 150 plus extremists is unacceptable."

He further stated, "The attack on the Ahmadiyya place of worship is an appalling act of religious intolerance. The illegal entry, destruction of property, and setting fire to belongings is unacceptable."

The spokesperson also expressed disappointment over the police's lack of action and said, "The police are not registering a case for the incident, and it is unfortunate that state institutions are targeting the oppressed class and delaying action, instead of taking immediate steps against extremist elements."

Ahmadis met with police officials and authorities for a rightful legal action against the attackers. At first, they were reluctant, but later the police registered a case with FIR No. 50 under PPCs 295, 427, 436, 147, 148, 149, 6 ATA and 7 ATA on May 4, 2023 in the police station Ghareeb Abad, District Mirpur Khas.

An anti-Ahmadi Ahmad Jan Sarhandi group is very active against Ahmadis in Sindh.

Talk on the issue of publicity of Qadiani products on social media

The minister's talk in this 2:13 video is rather garbled. It can, however, be assessed that it is about the publicity of some commercial products produced by a company with majority shareholders of Ahmadis (perhaps Shezan) in a brochure that was provided to pilgrims headed for Hajj. The minister expressed his 'intense pain' (Bara dukh hua) over this, and demanded 'urgent action' and a report from concerned authorities "within two days". He stated that the issue touched on the sentiments of the people involved in a religious ritual.

The senator has, regrettably, found it politically advantageous to go public on this non-issue. How could publicity of a Qadiani product in a brochure be so objectionable to the pilgrims, while they were all traveling on a plane, designed, produced, and marketed by non-Muslims? None of them was prepared to jump out of it. Also, he knows that Ahmadis from Pakistan, till the 1970s/1980s, used to perform Hajj, and those from other countries still do.

The minister unnecessarily got carried away by the complaints of a few bigots. He is enlightened enough to realize the demerits of such sentiments. Surely, the minister of a country, faced with its economic and political crises of May 2023, should have little time to attend to such frivolous and petty complaints.

The SHO sent for the local Ahmadis. What Ms. Hashmi said above is only the tip of the iceberg; these are only hints of what happened five years ago. We take this occasion to very briefly mention that story, as it will explain fairly the man behind this highly misleading tweet that engirdles simultaneously Zionists, Qadianis, Khalilzad, the army chief, and the Ahmadis living in Pakistan and the West.

Five years ago a rabidly anti-Ahmadiyya Mulla approached this Justice Siddiqui of Islamabad High Court to attend to some Ahmadiyya issues bearing upon the elections, and the administration of Ahmadis. - The newspaper Nation commented, ".... IHC should have the foresight to indicate the abuse and bloodshed such a law could open the doors to. Moreover, this order to make a sort of black list for Ahmadis, which is eerily reminiscent of concentration camps, is targeting of a religious group, and goes against the equality clause of the Constitution."

General of Rabita Aalam Islam (Muslim World League MWL) and the Chairman of the Organization of Muslim Scholars has recently come to our notice. In this, the Sheikh has responded to a statement made by the Chairman of the Justice Committee in the Swedish Parliament (Mr. Richard Jomshof). The Sheikh has condemned the Chairman's statement for being Islamophobic, divisive and hate-promotive. The Secretary General claims Islam to be a religion of tolerance, inclusivity, civilized interaction, and loyalty to the national state. He condemns extremism. The text of the Sheikh's statement is reproduced in Annex II to this report.

We find Sheikh Al-Issa's response very apt, balanced, and appropriate. It is based on the essential teaching of the Quran. He rightly refuses to counter abuse with abuse and recommends the Quranic approach of handling provocation and of Islam. hatred with wisdom and understanding. We Ahmadis support this response fully and wholeheartedly. We also endorse that this response is in accord with true Islamic teaching. However, there is a need for some candid soul-searching and fair assessment of the accusations leveled by the Chairman. As for soul-searching and self-assessment, it is not wrong to say that not all Muslims interpret Islamic teaching the same way as the Sheikh. A large number of prominent ulama and religious scholars, all over the Islamic world, these days do not echo the Sheikh's view. They, within their national borders, blatantly and persistently preach an alleged message of Islam that is contrary to his version. So there is a need to preach and propagate the Sheikh's view of Islam to Muslim scholars all over the Muslim-majority nations. More on this a little later.

The Chairman has lashed out at Islam and its alleged teachings. A brief mention of these allegations is in order before they are rebutted or acknowledged, that while these are wrongly traced to the Quran, they are surely the valid currency inside most Islamic countries these days. It is only after honest acknowledgment that the prevailing wrong can be put right.

The Chairman, in his article in Swedish, translated into English in https//Sweden.postsen.com/ local/89323/There-is-much-that-follows-from-Islam accuses Islam/Muslims of a long list of wrongs. Some of these are just allegations or misreading of history that have already been rebutted amply and effectively by enlightened Muslim scholars. These may be mentioned here but not rebutted, for lack of space. These are: 1. The Holy Prophet undertook offensive warfare, 2. He plundered to finance his continued warfare, 3. Most recently, in 2022, Khawaja Saad Rafiq, a federal minister tweeted, "Qadianiat and Zionism is a conspiracy to thrust a dagger in the heart of Islam". As per the Constitution, all citizens are equal, but religious minorities are less equal than the majority Muslims. Ahmadis' oppression is common practice in Pakistan, as it is considered a pious and meritorious act. Even a (former) high court chief justice formally observed, "Qadianis or people who have been declared non-Muslim should be identified and (criminal) cases shall be registered against those who distort Islamic teachings, which is a crime in Pakistan. The government should file a case against them — saying that private individuals should file a case, which is against the law". Imagine the kind of justice Ahmadis received in his high court while he was the chief justice. In the same jurisdiction a few months ago, a miscreant mulla led a police contingent to raid an Ahmadiyya Noor Academy and arrested its principal for allegedly distributing copies of the Quran as an award to some top students, accusing him of violating the Anti-Ahmadiyya and blasphemy laws. A judge refused to release him on bail. He remains in prison; if declared guilty, he could be imprisoned for life. In 2018, Justice Siddigui of Islamabad High Court wrote a 172-page verdict against Ahmadis without hearing a single Ahmadi for a single minute. Apart from other unworthy directives he even recommended special attire for Ahmadis and the surname of Ghulam Mirzai for all Ahmadis to facilitate the discovery of their religious identity — unbelievable, even unspeakable. In Pakistan, while the political system is democratic, implementation unabashedly violates the fundamentals and higher values of democracy. The country has been ruled by the military for decades. Anti-Ahmadiyya laws were promulgated by a martial law administrator. The Constitution lays down that only a (legal) Muslim can be the president and prime minister of the country. In the early days of Imran Khan's prime ministership, he appointed the renowned Professor Atif Mian (an Ahmadi) to his 18-member economic advisory council. In the subsequent protest of religious bigots, only two days later, he asked Atif Mian to resign from the council. that the PTI leader resisted the arrest, but police managed to arrest him after breaking the front window of his vehicle.... Mr. Elahi is wanted in a case related taking kickbacks in different development projects in Gujrat. A few days ago, his prearrest bail was cancelled by the court,....." (Anti-

Mr. Parvez Elahi, formerly of PML-Q, now president of PTI, is important to Ahmadis in Pakistan. In 2018, he became the speaker of the Punjab Assembly, and in July 2022 he took over as the Chief Minister with the approval of Imran Khan (PTI). Ever since, he has been mentioned in Ahmadiyya dispatches for his highly loathesome anti-Ahmadi activism. This will be briefly recalled in this story.

The authorities, however, arguably attribute his arrest to other wrong-doings. The federal Interior Minister tweeted: "His case is not that related to (the probability of) quitting the PTI. Parvez Elahi, in his recent tenure as chief minister indulged in immense corruption and blatantly undertook Farah Gogi's episode. He made billions in 10% 'commission' in contracts and turned green land to brown land. Moonis Elahi (his son) transferred dollars abroad in an aircraft." (@RanaSanaullahPK on 02 lun 23).

Ahmadis give due importance to things temporal, but also firmly believe in those of the heavenly and spiritual world. What Elahi was doing in the past five years (earlier too), made Ahmadis believe that he would not escape his retribution-eventually. He openly and rather blatantly used religion to promote his politics-particularly his anti-Ahmadiyya stance, in the name of Khatme Nabuwwat (End of Prophethood). He, appeared greatly successful for a while, but then he had to reap what he sowed. We mention below from the media reports only essentials in support of the quoted references without indulging in providing detailed references, as Mr. Parvez Elahi would fondly and proudly own up all that he said and did "to promote the cause of Islam".

Before we mention his most wrongful anti-Ahmadiyya activism, we mention how he requisitioned Islam to his politics.

- Under his speakership, Punjab Assembly, on the eve of the New Year 2019 passed a unanimous resolution asking the federal government to make new or improved laws to strongly punish blasphemers and set up a Saudi Arabia like central screening or filtration system to interrupt blasphemous material on social media..... (Note: On this, the steely human rights activist YL Hamdani wrote: "Instead of religion being the personal faith of an individual, it is currently the business of the state in Pakistan, indeed its only business." @theRealYLH-Dailytimes. com.pk/529370
- On July 2, 2020, ExpressRSS quoted him: Construction of a new (Hindu) temple in Islamabad violates the spirit of Islam: Parvez Elahi
- In year 2020, he proudly led the unanimous passage of Tahaffuz-e-Bunyad e Islam Bill in the Punjab Assembly. He called it a 'historic achievement'. He said "it will prove to be milestone on the record to protection (hifazat) and supremacy (sarbulandi) of Islam."
- While the Governor's signature were awaited, a keen and discerning look at the Bill found it highly divisive, thus unacceptable. If signed into law, it would have opened floodgates of strife as well as tyranny in the country. The federal government had to take notice—and no one has heard of this Bill, ever since.
- In December 2021, the press published his statement:
- Teachers should arrange prayers in school assemblies against smog and respiratory diseases: Parvez Elahi
- In November 2021, he showered undue praise on Ulama, "We recognize the role of Ulama in religious tolerance." This was the year when in April and October, mullas of the Tehrik e Labbaik precipitated violent and blood soaked anti-government campaigns.
- Mullas paid back the complaint. In their conference in Rabwah on September 7, Hafiz Tahir Ashrafi said. "Chief Minister Parvez Elahi is trying hard and has supported us a lot. Qadianis, you are nothing; we dealt with your elders as if dirt (jootiyon ki nok per rakha.)"

That should suffice. Now we move on to his special and favorite domain—anti-Ahmadiyyat.

- In May 2020, the Punjab Assembly, with Elahi in chair passed the resolution, "This House appreciates the federal cabinet which has not included the Qadianis in the Minority Commission..... Those people (Ahmadis) who are involved in these conspiracies should be exposed and given stringent punishment...... Matter of Khatme Nabuwwat is a red line for us."
- In 2020 again the PML-Q led primarily by Mr. Parvez Elahi, won the leadership contest in exploiting religion for political gain. He released a special video message on September 7, to commemorate the anti-Ahmadiyya 2nd Amendment to the Constitution, and called it the Day of Khatme Nabuwwat.
- In October 2021, The Punjab Assembly adopted a resolution to include End of Prophethood declaration in Nikah Nama (Marriage contract). Elahi said, "The declaration is essential to ensure that the groom is not a Qadiani."
- Elahi arranged in June 2021 that newly constructed hall of the Punjab Assembly carried Quranic verses and Holy Prophet's sayings regarding Khatme Nabuwwat. He, however, made sure that the Verses and Sayings which favor and support the Ahmadiyya understanding of the Finality of Prophethood (there are many) are not displayed at all.
- Sure enough, soon after being elevated to Chief Minister by Imran, he immediately promulgated the Notification concerning the Nikah Nama whereby the bride, the groom and others involved in marriage ceremony were to render an affidavit concerning End of Prophethood and also add that the holy founder of the Ahmadiyya Jamaat was a false (Jhoota) prophet.
- Malik Ilyas Awan, a Vice President of PML-Q Punjab wrote to the Deputy Commissioner from District Khushab (Punjab).
- In a video statement, in September 2022, Mr. Elahi can be seen and heard expressing his intentions to build another grand Blue last.

Mosque, like the one in Turkiye. He added, "It will be boldly written on the exterior that no Qadiani is allowed inside. We have no friendship nor any dealing with one who does not believe in the End of Prophethood. If they want to stay, they may, as a minority. We'll give them rights as we give rights to Christians and Hindus, (but) if they opt to leave, they should do so."

- During his tenure as the Speaker and the Chief Minister, 28 Ahmadiyya mosques were destroyed, damaged, sealed, etc. and 374 Ahmadis' graves were vandalized, mostly by authorities. Unbeatable statistics
- Most recently, in a video, he says, "(Ahmadi Lobby)...... We are determined (concerning them). I, as the Speaker (of Punjab Assembly) and (then) as the Chief Minister (pushed them) to their real abode (asal jagah), and go where they have to go." Haqiqat TV

People were watching and taking note of Parvez Elahi's religious antics. The Friday Times could not resist producing an op-ed titled: A religio-political dilemma—How far Can Parvez Elahi Afford to Take Anti-Ahmadi Bigotry in Punjab? HRCP warned Punjab Assembly of fueling bigotry, on July 24, 2020. An Ahmadi-origin comment pleaded: Mr. Parvez Elahi and other of his ilk, the drumbeaters of Islam, should have some pity on the Land of the Pure, Islam and themselves, by distancing from bigotry, hate promotion, intolerance and division in the fair name of Islam.

Mr. Parvez Elahi is now in the lime light. Even in 2018, the Supreme Court summoned him in Bahria Town case. More recently, FIA was told in February 2023 to act against him after audio leaks. In April 2023, the Dawn reported, "ACE (Anti-Corruption Establishment) registers another FIR against Bhatti (former Principal Secretary to Mr. Parvez Elahi)." In the same month, Anti-Corruption Establishment probed into illegal PA postings by Elahi himself. He is facing charges, arrest, and trial in courts these days. The same Imran Khan who has now given him the presidency of PTI, earlier called him Punin July 2022 asking him to expel all Ahmadis jab's biggest robber (Punjab ka sab se bara dakoo). An application was sent by the opponents to the DSP Gojra in which the plaintiff Usman Munawar advocate took the position that the Special Branch issued a list of mosques for security measures on the occasion of Eid-ul-Fitr; the Ahmadiyya place of worship "Bait-ul-Hamad" was also included in the list.

In his application, apart from the In-charge Police Station City Gojra, the plaintiff included Mr. Khalil Ahmed and Mr. Ali Raza, Ahmadi residents of Gojra. He stated that on his visit to the said police station, he saw the list on the notice board, and found the Ahmadiyya place of worship mentioned there-

in; and the word "Ahmadiyya" was also written in the box of religion, meant for Muslims. According to the Constitution of Pakistan, they are non-Muslim and not related to Islam, he said. Security has been provided to the Ahmadiyya place of worship by the In-charge police station, the bigot added.

The applicant further wrote that according to the Constitution of Pakistan, Qadianis are not Muslim, nor can they practice any Islamic rituals, pretending to be Muslim. Therefore, action should be taken against the mentioned individuals, he demanded. It is noteworthy that Ahmadis had no role in preparing the said lists, nor with organizing police protection.

AHMADIS BEHIND BARS

Mr. Rohan Ahmad, Malik Usman Ahmad and Hafiz Tarig Shehzad, etc. were booked on May 26, 2020 with FIR Nr. 29/2020 at Police Station FIA Cyber Crimes Wing, Lahore under PPCs 295-B, 298-C, 120-B, 109, 34 R/W, 2016-PECA-11. Pakistan's Cyber Crimes Department, Lahore that works under Federal Investigation Agency, arrested Mr. Rohan Ahmad.

Malik Usman Ahmad and Hafiz Tarig Shehzad were arrested dated 30.09.2020 on reporting to the FIA office; they are in Camp Jail Lahore.

Syed Ali Abbas, Addl. Sessions Judge Lahore added the blasphemy clause PPC 295-C to the charge sheet on June 29, 2021. Thus, they are now exposed to penalty of death.

The SC rejected their post-arrest bail application. Now Rohan's bail is pending before High Court on the statutory ground i.e. trial is not concluded within 2 years of the arrest of the accused.

Mr. Mubarak Ahmad Sani was arrested on January 7, 2023 from his home in Rabwah. He was booked with FIR Nr. 661/22 under sections 295-B. 298-C and the Punjab Holy Quran (Printing and Recording) Act 2011. He was sent to Jhang Jail after judicial remand and later transferred to District Jail Faisalabad. His bail application is pending in the court of Additional Sessions Judge Lalian, District Chiniot.

Malik Zaheer Ahmad was arrested on September 30, 2020 in a fabricated case under Sections 298-C, 295-B, PECA-11 and 109. He was granted bail on February 23, 2021 and was expected to be released in four to five days after paper formalities. On February 27, when Malik Zaheer Ahmad was expected to be released from the Camp Jail, the Cyber Crime Wing Lahore team arrested him under FIR Nr. 88 as outlined in the above case, under PPCs 295-A, 298-C, PECA-11. He was not even formally nominated in the case.

His plea for bail was rejected by SC.

Mr. Shiraz Ahmad etc. were booked by Cyber Crime Police Station Lahore on June 20, 2019 under FIR Nr. 88, under PPCs 295-A, 298-C, PECA-11, for allegedly creating a group "Sindh Salamat" and allegedly sharing Ahmadiyya content in it. He was arrested from Hafizabad on February 25, 2021. Subsequently the trial court added section 295-C of PPC to the said case.

His plea for bail was rejected by SC.

The police booked Syed Ali Ahmad Tariq under PPC 298-B with FIR No. 54 on April 27, 2023 in the police station City Court Karachi. He was arrested and sent to jail.

He was expected to be released on bail on May 27, 2023, but due to a production order in a case with FIR No. 121/1992 in police station Shahdadpur district Sanghar on October 20, 1992, his release has stalled.



Omar Sial, J.: I have had to adjourn all bail cases today because of grave apprehension of a law and order situation developing within the court premises in connection with a post arrest bail application, pending adjudication.

2. In the previous hearing of this case, extremely unprofessional, in fact, despicably aggressive behaviour was resorted to by some advocates. The Sind Bar Council, Sindh High Court Bar Association, Karachi Bar Association and Malir Bar Association, in particular, should take immediate action to address the unacceptable behaviour of some of its members. Their behaviour was a slap on and a disgrace to the prestigious profession of law. It is shameful that such persons are permitted to even use the word "advocate" with their names. Their conduct was a black mark on the pride, dignity and reputation of the entire legal fraternity. This Court showed immense judicial restraint in face of clear contemptuous and threatening words and acts. Restraint was also shown in the face of the hostility this Court was subjected to by some advocates. Restraint was shown so that the professional lawyers, court staff and court property could remain protected. The belligerence shown by some advocates, however, will not prevent this court from deciding the cause before it on its merits, as indeed it does each case before it. I am well aware of, and intend to faithfully follow my oath of deciding without fear or favour.

Let a copy of this order be sent to the Sind Bar Council. SHCBA, KBA and MBA so these entities can play their respective parts in weeding out the black sheep amongst them. The belligerence and unprofessional behaviour was on part of the advocates registered with these bars, and not the litigant who was in court. Not only an attempt was made to intimidate the court and interfere in the smooth administration of justice, but a lawyer, identified as Akbar Jatoi was physically abusive towards Mr. Salman Mirza, one of the learned counsels for the applicant. Mr. Salahuddin Ahmed, another learned counsel for the applicant, was intimidated, abused and threatened. This was simply unacceptable behaviour and conduct and must necessarily be condemned by the Bar Associations and Councils. The regulatory body of advocates should very seriously look into it this and take action to maintain the glory of the profession. Whether or not the learned counsel who was assaulted in court files a criminal action or not is a decision that is best left to learned counsel to make. CCTV footage of the court premises will no doubt show the outrageous and unacceptable behavior of the offending advocates. The offending advocates appeared ignorant that Rule 134 of the Legal Practitioners and Bar Councils Rules, 1976 stipulates that, "It is the duty of every advocate to uphold at all times the dignity and high standing of his profession, as well as his own dignity and high standing as a member thereof". 4. Courts of law are places where once one enters one should feel free to express his grievance and to demand that he or she be dealt with in accordance with law. Article 25 of the Constitution, that everyone is entitled to equal treatment of law, must not be lost sight of. Neither should the rights of a fair trial contained in Article 10-A be ignored. Quite ironically, some of the very advocates who created trouble in court, quite hypocritically, pose as champions of the right of fair trial and human rights when it comes to their own cases. Advocates should be the last people on earth to prevent a litigant from achieving this right.

5. Let this file be placed before the Honourable Chief Justice with the request that the Registrar be directed to put appropriate security measures in place on each date of hearing in this case. Only the parties and their counsel should be allowed in Court so that this Court can ensure that a fair trial is given to the accused. The security requested is not for the judge but to ensure that the respect and dignity of the courts of law is not attacked by some unscrupulous hooligans in the garb of advocates.

6. Re-list this case on Monday 22.05.2023 at 9:00 a.m. Only parties, counsels restricted to 2 a side will be allowed in the Court room. Members of the press will also be allowed so that a transparent hearing takes place. Office to send a copy of this order to counsels for both parties and the learned Prosecutor General. The learned Prosecutor General should either appear himself in this case or assign it to a seasoned and experienced prosecutor.

The Muslim World League condemned the statements made by the Chairman of the Justice Committee in the Swedish Parliament against Islam, the Holy Qur'an, and our Prophet Mohammed, peace be upon him, the messenger of mercy and kindness.

His Excellency Sheikh Dr. Mohammed bin Abdulkarim Al-Issa, the Secretary-General of the Muslim World League and the Chairman of the Organization of Muslim Scholars, said in a statement that this attack on our religion [Islam] from someone who does not only represent himself but is also a person of prominence, given his position as the chairman of the Justice Committee in the Parliament, is a clear indication of the rise of Islamophobia in the official entity this person heads. Sweden has a distinguished relationship with the Islamic world, the Swedish people are appreciated and respected by Muslims, they are described as civilized and friendly people, and they still are. These negative and immoral words only represent the person who expressed them and the entity he heads.

The MWL statement pointed out that the insults reflect an ignorance of the true Islam, they are based on concepts promoted by extremists, which are not related, in any shape or form, to the true and tolerant message of Islam, these concepts crumble in the face of the facts that have convinced over two billion Muslims across the world. He forgot that his insults apply to all extremist groups that exist among a section of the followers of all faiths, and not only among those who are outwardly claimed to be affiliated with Islam. This abusive person must get the truth from the original sources and carefully read history.

Dr. Al-Issa called upon the many sources of good in the Swedish society to stand in the face of this growing tide that seeks to create a rift between Muslims and other members of the Swedish society, as well as between Sweden and the Islamic world, based on extremist concepts that fuel the call for clash and conflict between civilizations. We firmly believe that the Swedish consciousness represented by all of its national components, will not allow bets that would compromise national and human values that believe in fraternity, love and mutual respect in Sweden, as well as in friendship between nations and peoples, and attempts that undermine the importance of promoting the alliance between civilizations based on shared human values.

Sheikh Dr. Al-Issa considered the insistence on practices that incite hatred and provoke religious sentiments cannot be justified under any pretext, whether against Islam or any other faith, culture or race. If such behavior is practiced as a form of freedom. then it is an abuse of this humane concept: because the values of freedom, based on the natural law, do not allow for the insulting of others, let alone allow for creating animosity with hundreds of millions of Muslims who love the world they live in and engage with it in a civilized manner according to their religious and patriotic principles. Especially, the Muslims of Sweden who love their country, they are proud of it and are ready to sacrifice for its sake.

Sheikh Dr. Al-Issa affirmed that the aforementioned statements will only serve extremist agendas, will silence the voices of reason and will undermine the efforts of bridging the gap and building bridges between nations and peoples.

His Excellency, the Secretary-General, warned Muslims in Sweden and the rest of Europe, not to be drawn into the space that extremists are luring them into by creating an atmosphere of mutual hatred among the various components of the society. Dr. Al-Issa stressed that such statements should increase Muslims' adherence to their values that emphasize the necessity of building and not destroying; getting closer rather than growing apart; the keenness to make societies stable and not to disturb harmony; they also stress the importance of bonding around the national state based on the constitution and laws of each country, whatever the identity may be

His Excellency affirmed Islam is against countering abuse with abuse, and against any negative behavior; whether in word or action, including actions that violate the laws, especially those that provoke hatred and escalate matters. To deal with such matters we need wisdom, we need to turn away from them, this is the approach of the Holy Quran, as mentioned in several verses, and so was the approach of our Prophet Mohammed, peace be upon him, as was the case in several such incidents.

In conclusion, Dr. Al-Issa said that Islam is a true religion that cannot be harmed by provocative words or actions. Throughout its history and its exponential growth, with more than two billion followers across the world, Islam was never affected by those who attempted to target it, the adherent of Islam believe in it as a religion of mercy and peace for humanity at large.

DECLARING AHMADIS AS NON-MUSLIMS

THE PAKISTANI RELIGIOUS ESTABLISHMENT BRANDS THE AHMADIYYA COMMUNITY HERETICAL IN NATURE AND DOES NOT APPROVE OF ITS REFORMATORY NATURE. POLITICIANS HAVE ALSO FOUND IT EXPEDIENT TO SUPPORT THE RELIGIOUS ESTABLISHMENT IN THEIR ANTI-AHMADIYYA STANCE. THE FIRST COUNTRYWIDE WAVE OF VIOLENCE AGAINST THE COMMUNITY ERUPTED IN 1953. FOLLOWING THE EXTENSIVE RIOTS, AN IN-DEPTH JUDICIAL INQUIRY BY THE CHIEF JUSTICE AND A JUDGE OF LAHORE HIGH COURT FOUND POLITICS TO BE THE MAIN CAUSE OF DISTURBANCES. ORDINANCE XX

FOLLOWING BHUTTO'S LEAD, GENERAL ZIA UL HAQ, THE MILITARY DICTATOR OF PAKISTAN FROM 1977 TO 1988, TRIED TO COURT EXTREMISTS BY PROMULGATING THE NOTORIOUS ANTI-AHMADIYYA ORDINANCE XX IN 1984. THE ORDINANCE ADDED SECTIONS 298-B AND 298-C TO THE PAKISTAN PENAL CODE. THROUGH THIS ORDINANCE, THE RELIGIOUS RIGHTS OF AHMADIS WERE DIRECTLY VIOLATED. UNDER ITS PROVISIONS, AHMADIS COULD BE IMPRISONED FOR THREE YEARS AND FINED AN ARBITRARY AMOUNT FOR ORDINARY EXPRESSION OF THEIR FAITH. ADDITIONALLY, TO PROHIBIT AHMADIS FROM PROSELYTIZING, IT EXPRESSLY FORBADE THEM FROM CERTAIN RELIGIOUS PRACTICES AND THE USAGE OF ISLAMIC TERMINOLOGY. THIS ORDINANCE EFFECTIVELY MAKES A CRIMINAL OUT OF EVERY AHMADI BY INCLUDING THE BROAD PROVISION OF "POSING AS A MUSLIM" A COGNIZABLE OFFENCE, GIVING THE EXTREMISTS À CARTE BLANCHETO TERRORIZE AHMADIS WITH THE BACKING OF THE STATE.
