### RELIGIOUS CARD BY THE ANTI-AHMADIYYA RALLIES & CONFERENCES

Whilst the government has banned all outdoor rallies & conferences of Ahmadis even in their headquarters in Rabwah, the anti-Ahmadiyya elementns hold open hate mongering rallies and conferences throughout the country. # **MINARET OF THE AHMADIYYA MOSQUE**

# **DEMOLISHED BY THE POLICE**

Gojra, District Toba Tek Singh; September 13, 2022:

The police, on demand of religious bigots, destroyed the minaret of the local Ahmadiyya mosque. Two men came here and took pictures and videos of the minaret on September 12, 2022. The next day, a police vehicle came, and an intelligence officer told Ahmadis that a complaint had been filed against the minaret. Later on, the DSP sent for Ahmadis. The DSP showed them the pictures and videos and told them to demolish the minaret. The Ahmadiyya delegation asked for some time to consider the demand. The DSP said that there was no time, and he told Ahmadis to do this forthwith, and shift the families, residing there, to another place due to the threat of an attack (by miscreants).

The Ahmadiyya delegation conveyed to the police officers that they will not remove the minaret themselves. The police officials threatened Ahmadis to hold them responsible for any riot.

Later, the DSP and SHO along with 13 policemen came around 12 o'clock and destroyed the only remaining minaret of the place of worship, as the other one was demolished back in 1974 by the rioting mob.





# **UNLAWFUL DEMAND**

# **AGAINST AHMADIYYA MOSQUE**

Bhlair, District Kasur; September 15, 2022:

Tehreek Labbaik (TLP) took out a procession here in which almost all the participants were outsiders. The police of the nearby village whose people were participating in the procession accompanied the trouble-makers. The police came to the Ahmadiyya mosque on the complaint of Rana Nazar Hussain, who is not a resident of this village. The SHO visited the mosque and told Ahmadis to take down the minarets by 10 o'clock next morning, claiming these to be against the law. He was wrong; there is no law that Ahmadiyya place of worship cannot have a minaret or niche. He threatened Ahmadis with the registration of an FIR in case of non-compliance.



An Ahmadiyya delegation met the DPO and submitted a written request. The DPO said that whatever happens will be dealt with

according to the law. He further stated that Ahmadiyya place of worship in Patuki does not have any minarets, so you should also remove them from here. After that, a meeting was held with the DSP. He stated that the issue would be handled as per law. He phoned the SHO and stopped him from taking action until Monday. On September 17, the local Ahmadi president was informed that a few boys of the TLP were heading towards the village. It was feared that a procession would follow. Similarly, the SHO also came over and told Ahmadis to comply with the previous orders of taking down the minarets to resolve the issue.

Ahmadis were made to write an affidavit affirming that the niche and the five minarets will be covered so that passersby would not be able to see them. Ahmadis have undertaken to hide the niche by a surrounding wall in the adjacent plot and by installing cement or fiber sheets etc to cover the minarets.

The place would look ugly, so would the village; but the TLP and the authorities have little aesthetic sense for their own reasons, when dealing with Ahmadis.

# MINARETS OF AHMADIYYA MOSQUE

### **UNDER THREAT**

Martin Road, Karachi; September 16, 2022:

On September 16, Police and Rangers came to the Baitul Hamad, Martin Road, Karachi and met the local Ahmadiyya president. They said that people have objections against the minarets on the Ahmadiyya mosque, so Ahmadis should remove these to put an end to the issue. The president told them that these minarets are old and he would not remove them. The officials said that they knew that Ahmadiyya Jamaat is a peaceful Jamaat and this worship place is quite old but some people come to the police station with complaints every day. The officials solicited cooperation from Ahmadis.

Thereafter the police sent for the Ahmadiyya delegation to the police station on the same day. The SHO confirmed that the worship place was old but the

mullas have approached high officials for removal of minarets. Ahmadis told him that they are law-abiding, and there is no law against minarets on Ahmadiyya places of worship. According to the law Ahmadis are not allowed to call their mosque a 'Masjid' so they follow it; there is a ban on the Adhan (call for prayer), they do not call Adhan. Ahmadis do not have big loud speakers in their mosque. If these opponents say tomorrow that Ahmadis' names are the same as theirs or they breathe like them or they walk like them, will he still call them at fault? they added. "If it is written somewhere in law that minarets are illegal, then give us that quote and we will seek guidance from our elders", they argued. Their argument was weighty, and the issue rested there.

# ATTEMPT TO TORCH AHMADIYYA MOSQUE

Rawalpindi; August 30, 2022:

Unidentified miscreant tried to set Ahmadiyya mosque on Murree Road on fire with petrol, at around 12:30 a.m. However, he did not succeed in the attempt. The matter was reported to the police. So the police inspected the site on 13 September 2022, and examined the nearby streets, and made enquiries from the neighborhood and the shopkeepers. The senior police officers showed adequate concern with the attempted arson.







### **PROBLEM IN WORSHIP**

**Lahore:** Karak House in Lahore is an Ahmadiyya property. The local community is facing problems in using it for religious purposes.

The only legal restriction on Ahmadis is to not call their mosques 'Masjid' (PPC 298-B). Ahmadis in Pakistan abide by that, but anti-Ahmadi elements expand it at will to deny Ahmadis religious assemblies of any kind. Ahmadis are not allowed to build places of worship, and if they get together in small numbers at private locations for religious purposes, they are obstructed to do that.

Karak House is one such place. The mulla is active for years to deny Ahmadis its use for religious purposes. Some in the official circles lean towards Ahmadis to provide some semblance of freedom of worship, while there are others who think that a denial to Ahmadis will improve their felicity in the Afterlife.

The Military Estate office has recently sent a fresh Notice to Ahmadis. The issue is sub-judice as well. The Law Ministry is also involved.

One wonders why the authorities are not moved by their Constitutional and International commitments to FoRB to Ahmadis, and thereby chinch this non-issue.

# FOUR AHMADI CHILDREN EXPELLED

### FROM SCHOOL FOR THEIR FAITH

### Mithial, District Attock; September 22, 2022:

International Human Rights Committee issued the following Incident Report on September 24, 2022 (extracts): CHILDREN IN PAKISTAN EXPELLED FROM SCHOOL JUST FOR BEING AHMADI MUSLIM WITH BLATANT DISCRIMI-NATION & DENIAL OF RIGHT TO EDUCATION

A school in Pakistan has expelled four Ahmadi students merely on the basis of their faith and belief.

In a shocking expulsion document, the franchise of The Educators Schools Network in Attock, Pakistan blatantly violated the basic human right to education.

In its expulsion document, the Principal wrote:

"The following students who were studying in this institute are being withdrawn on the basis of Qadianiat [a derogatory term for Ahmadis] Religion."

We add the following information and developments received subsequently. These children were studying in this school, The Educators (Mithial Campus), for the last three years. Their names and classes are as follows:

•	Miss Hazifa Nasir	Class III
•	Miss Anila Aaqib	Class VI
•	Mr. Abir Ahmad Saifi	Class IX
•	Miss Namrah Qureshi	Class X

Anti-Ahmadi hate campaign has gone on in this area for long, and the authorities have done little to confront it or reduce it. For example, a cricket tournament is held regularly in Kasran, and the publicity posters mention specifically: "Qadianis are not allowed to participate in it." The authorities let it pass as if un-noticed.

This hate-campaign had entered this school as

well and the Ahmadi children faced ill-will, ridicule and harassment from some of their fellow students and even some teaching staff. Reportedly there was pressure, internal as well as external, on the lady principal to throw out the Ahmadi students. It is learnt that the principal, unwillingly and woefully, issued the following certificate:

"The following students who were studying in this institute are being withdrawal on the basis of Qadianiat Religion.

"Institute is unable to keep continue their study from now onward." (sic)

The issue got publicity on social media etc, and some sections of H.R. organizations, journalists and civil society expressed their concern over it. The BBC issued a report on the incident in its bbc.com/urdu; so did the independenturdu.com. As a result, some senior officials in the district administration, education, police and the school management had a meeting with the parents of the victims and decided to step backward from the expulsion of the children from the school. The principal was good enough to apologize over the incident.

The school administration, thereafter, asked the parents to sign a statement of reconciliation. The parents felt hesitant to do that without further consultation and deliberation, as sending the children back to the school in the resultant atmosphere of greater hostility and prejudice might be of the unacceptable degree.

# **FABRICATED APPLICATION**

### AGAINST AHMADIS FILED IN A COURT

Chak No. 46 North, District Sargodha; Septemplace of worship was old. There are two small minarets ber 2022:

Mr. Asad Akram Khachela, son-in-law and nephew of Muhammad Aslam Khachela, filed a petition with the Sessions Judge against seven Ahmadis under section PPCs 22-A and 22-B. He complained against mosquestyle minarets on the Ahmadiyya place of worship, copy of Quran with Ahmadiyya translation and a booklet written by the founder of Ahmadiyya Community etc. He accused Ahmadis of committing a crime by building their place of worship in the style of a mosque and storing hateful material. He demanded registration of a criminal case and severe action.

The judge told the police to inquire and report. community, the police reported. The police did the investigation and reported that the

and no loudspeaker is installed. No audible call to prayer is made. The minarets are 45-46 years old, and no impartial evidence is available regarding the distribution of pamphlets. The petitioner has neither appeared nor produced any local person in support of the allegations. Tariq, who had been named in the application regarding the advertisement, stated that the statement in the application was not presented to him. His name was deliberately included in the application without his consent. Similar requests were made earlier by the two parties. The application has been found to be fabricated and baseless. It has been made only to pressurize the Qadiani

The case remains sub-judice.

# THREAT CALL **TO AN AHMADI**

### Rawalpindi; September 2022:

Irfan Ahmad Qureshi, Ahmadi, received a call from a private number that did not appear on the screen. The caller identified himself as a member of the Al-Mujahid organization and asked Mr. Qureshi, "Are you a Qadiani?" When he answered in the affirmative, the caller used abusive words for Mirza Ghulam Ahmad Oadiani, the founder of Ahmadiyyat. The caller threatened him to remain alert as he was pursuing him.

Mr. Qureshi has been living here for the past 43 years and the people of the area know that he is an Ah-

# HATEFUL RALLY **IN SARGODHA**

### Silanwali, District Sargodha; August 24, 2022:

An anti-Ahmadiyya rally was held here in the name of Khatme Nabuwwat. The participants went over to Ahmadis' homes in Rehmat Colony and abused them on August 24, 2022.

The next day, a Tahaffuze Khatme Nabuwwat Conference was held here in which mullas from different districts participated. Hateful and provocative speeches were made against Ahmadis and the founder of their community. The speakers forbade the audience doing business with Ahmadis and urged them to implement a social boycott of Ahmadis.

They claim that all the sects in Silanwali have formed a joint organization against Ahmadis.

# **AHMADI SEVERELY HARASSED**

# Samanabad, District Faisalabad; September

Mr. Abdul Hanan used to work in a private insurance company in Samanabad, District Faisalabad. He was an efficient worker, so another company invited him to join in a senior position. He did that, but his colleagues became jealous and proceeded to harass him on basis of faith.

Applications were filed against him in Sargodha city and Jhal Chakian police stations that Abdul Hanan is an Ahmadi and preaches his faith.

His ex-colleagues are among the complainants against him, and a follower of mulla Akram Toofani of Jhal Chakian filed another petition. He is liable to be booked under blasphemy laws by the police.

Under overwhelming stress, he decided to disappear.

# **NEIGHBORS** PROMOTE HATRED

### Sharqpur Khurd, Kot Abdul Malik, District Sheikhupura; September 2022:

Mr. Basharat Ahmad, Ahmadi, faces opposition from his neighbors. A few days ago, his neighbor invited a hostile mulla, Irfan Mahmood Burg to his house and organized a gathering. The mulla bad-mouthed Ahmadiyya Community and urged a social boycott of Ahmadis, forbade trade with them, told the audience to take legal action if an Ahmadi extends them Salaam. He promoted hate and violence in the audience, against Ahmadis.

# **AHMADI RECEIVES THREATS TO LIFE**


Khana Mianwali, District Narowal; September 2022:

Mr. Saif ur Rehman is a practicing Ahmadi. He is a businessman. A non-Ahmadi, Muhammad Waris, demanded a free spray machine from Mr. Rehman. On September 17, 2022, Waris telephoned Mr. Rehman and repeated his demand with threats that he was a Mirzai who

is Wajib ul Qatl (must be killed) and he could kill him, etc, and used extremely foul language. Mr. Rehman went to the police station and filed a complaint against him, on which the police arrested Waris. While in custody, Waris repeated his earlier statement that Rehman was a Mirzai and is Wajib ul Qatl (must be killed) etc.

# **UNBELIEVABLE, BUT TRUE**

On twitter, September 18, 2022: Khawaja Saad Rafique, a PML-N federal minister, in a recent tweet, stated that:



"Qadianiat and Zionism is a conspiracy to thrust a dagger in the heart of Islam," etc.

The minister has perhaps gone insane; we do not know, why. His tweet is

confirmed as not fake. It refers to a tweet by a more sensible minister, Mr. Miftah Ismail. We produce below the three relevant tweets.

Initially, someone tweeted the following fabrication from an address @MusadiqMalik:



"Qadianis are the world's worst and filthiest infidels, and equally filthy is their every supporter.

Those who agree, should continue to retweet."



This is a fake account. An imposter pretending to be Musadik Malik. His real account is @DrMusadikMalik

The real Dr. MusadiK Malik is a PML-N leader and a minister of state in the incumbent federal government. Reportedly he is relatively a decent person, and someone issued the above offensive tweet from a fake account as intimated soon afterwards by Mr. Miftah Ismail, the federal finance minister, in the following tweet from his address @Miftahlsmail:

So far so good, but then Khawaja Saad Rafique jumped

in this one-sided foray and fired his unsolicited broadside on Ahmadis — a very soft target. It is in vernacular; we present it in original and attempt an "Qadianiat and Zionism English translation that may not be able to do justice to the evil language used in the original.

The next day Punjab Assembly condemned this federal minister for invoking the religion card. (The daily Dawn, Lahore September 20, 2022)

A few days earlier, another PML-N federal minister Mr. Javed Latif in a TV appearance accused Imran Khan, though falsely, of pro-Ahmadi leaning.

In the following days, Mr. Latif's remarks attracted a great deal of criticism from many quarters. Mr. Aitzaz Ahsan, a well-known politician and lawyer came to the conclusion:

"Religion card: Javed Latif wants Imran Khan murdered: Aitzaz Ahsan" on TV channel ARY at 0705 on September 21,2022.

It is now up to Mr. Shehbaz Sharif, the Prime Minister to decide whether Mr. Saad Rafique and Mr. Javed Latif are fit to hold the posts of minister in his cabinet, who unscrupulously use religion and race to promote their politics, doing irreparable harm to the reputation of PML-N that claims lineage from Muslim League of the Ouaid e Azam.

### **TALKS OF BLOODSHED**

Islamabad, September 14, 2022:

TV channels the official PTV and the private Geo News aired a video statement today of Mian Javed Latif, a PML-N federal minister. In this, inter alia, he is seen criticizing the rival PTI chief, Imran Khan by accusing him of tilt towards Ahmadis thus committing a great religious faux pas. We produce its translation below:

"(The question is) Whether you supported Imran Khan or not?

"(Then what about) the attack on the foundational issues of Islam and providing nourishment to Qadianiat! When he initiated the 'New Pakistan', didn't every Qadiani unit in Karachi become active? Was this a mere coincidence? Also, on push from a professor, students of the Lahore Management University were driven to Rabwah with official protocol and were made forcibly to express solidarity with Qadianis. Was this also a mere coincidence? And, didn't Imran Khan tell foreign media prior to assuming power, that if he came to power, the Qadianis would enjoy religious freedom? Every institution (Idarah) should consider and play its role in that if this mischief (fitna) gains momentum, Pakistan will be immersed in such bloodshed (khoon raizy)...."

Mian Javed Latif MNA, at present is Chairman Standing Committee on Information, Broadcasting, National History and Literary Heritage.



### The next week

Minister Javed Latif had planned to hit two birds with one stone. He was quite safe from Ahmadis, but the other bird, Imran Khan has huge claws who attempted to lift him up and drop him from a well-deserved height. The daily Dawn of September 20 printed a two-column headline: Ministers booked for 'endangering Imran's life. Senate body takes 'stern notice' of Latif's speech. Extracts from the Dawn report:

"LAHORE/ISLAMABAD: Punjab police on Monday booked two PML-N ministers, as well as two senior officials of state run PTV on terrorism charges for allegedly 'fanning religious hatred' against ousted prime minister Imran Khan and endangering his life.

"Green Town police registered an FIR under Section 9 (punishment for acts intended or likely to stir up sectarian hatred) and Section 11X (3) (responsibility for creating civil commotion) of the Anti-Terrorism Act of 1997 against Federal Information Minister Marriyum Aurangzeb, Federal Minister Mian Javed Latif, PTV Managing Director Sohail Khan, as well as the broadcaster's Controller Programmes, Rashid Baig, on the complaint of a local prayer leader.

"Mr. Latif had, in a Sept 14 press conference, declared the Pakistan Tehreek-Insaf (PTI) chairman a 'non-Muslim' and supporter of the Ahmadiyya community. The FIR accused Mr. Latif of "consulting" Ms. Aurangzeb in relation to his press conference and organizing it in collaboration with her, the PTV managing director and the broadcaster's controller programmes. The individuals have been accused of endangering Mr. Khan's life through their actions.

### **Ghoghyat, District Sargodha; September 2022:**

Opposition to Ahmadis has intensified in Ghoghyat, District Sargodha in the last 5 years. In May 2022, the police desecrated thirty gravestones of Ahmadertaking Qurbani on Eid ul Adha. Opponents submitted numerous applications at different levels against minarets and niche of the Ahmadiyya mosque.

On September 10, Malik Muhammad Yaqoob, Head of the notorious Tehrik Labbaik Pakistan (TLP) in Sargodha Division, released a video message in which he said, "Since 2019, we have made requests against the use dis on demand of mullas. Ahmadis were barred from un- of Islamic rituals by Qadianis in Ghoghyat, but no one heard us. If the district administration removes the minarets and niche from their place of worship by September 12, then fine, otherwise the locals along with the TLP

On September 13, the district administration held a meeting with TLP, after which the said mulla issued another video message that the negotiations with the police were successful and the people should remain peaceful.

In this meeting, besides removal of the minarets and niche, the mullas presented the following 8 points:

- 1. Qadianis may not say Salaam in public.
- 2. Qadianis cannot participate in Muslim funerals.
- Qadianis should be forbidden to invite Muslims to their marriage ceremony.
- 4. Qadianis cannot participate in the marriage ceremony of Muslims.
- 5. Qadianis should be forbidden to promote Quranic teachings (Taleem).
- 6. They should be forbidden to carry the Holy Quran ban under duress.

- 8. No Qadiani should offer rituals prayers in public.

In this regard, Ahmadiyya delegation spoke to the administration and police officials. The police said that a committee would be formed on the minarets and niche; it will report on the construction of the mosque and how old the mosque is. Also a board will be displayed outside the mosque, which will read, "This is not a Muslims' mosque; it is a place of worship for the (Qadiani) Jamaat". On this, Ahmadis offered that instead "Bait-ul-Ahmadiyya" could be written there. However, after the Friday prayers, the police installed their board on the road outside the niche of the Ahmadiyya mosque.

It may be recalled the TLP is a violent sectarian political party that thrives on religious bigotry. It undertook a march to Islamabad in October 2021, wherein their crowd managed to kill 8 persons including policemen. It was initially banned, but later the authorities lifted the

A video of Tehreek-e-Labbaik Pakistan (TLP) leader directly inciting violence against Ahmadis – especially pregnant women – is doing the rounds on social media. In the video, Qadri is giving a 'sermon' to his followers, telling them to actively carry out attacks against Ahmadis especially pregnant women so as to stop the baby from being born.

"We are the descendants of Mehmood of Ghaznavi," says the cleric from the previously banned outfit in the video. "He was such a lionheart of the Holy Prophet (PBUH) whose horse's galloping sound, would cause the miscarriage of Hindu women."



He then continues to incite the listening audience, to 'raise the slogan of Tajdar-e-Khatm-e-Nabuwat (the Seal of the Prophethood) with such ferocity that causes the "Mirzai" (pejorative for Ahmadis) women to lose their unborn child in their womb.'

In the six-minute video, the leader who is the district head of the Mandi Bahauddin area, he does not stop there but goes on with his hate-speech.

"Such a blasphemer should not be born, and those that are born we will not leave them alive," he said referring to those from the Ahmadi community.

He also goes on to address the law enforcement agen-

"Those of you who are from the agencies, or if there is in the country which endangers countless innocent any DPO (District Police Officer), District Commissioner or SHO (Station House Officer) present here, listen very carefully and attentively. That dog came here one time to ment to honour its responsibility to provide adequate preach, we won't allow him a second time." It is unclear if he was referring to anyone specific, but the warning was clear for the LEAs if they attempted to provide protection to Ahmadi families.

TLP has a history of carrying out attacks against the Ahmadi community including the murder of Naseer Ahmad in Rabwah, in August 2022.



Rabwah; September 28, 2022: Ahmadiyya central office forwarded the following request in writing to authorities to disallow mullas' sectarian conference and processions in the Ahmadiyya town Chenab Nagar (Rabwah), scheduled on Holy Prophet's birthday.

Title: Request for appropriate action on the occasion of 12th Rabi-ul-Awwal on October 09, 2022 gatherings and processions at Rabwah/Chenab Nagar, District Chiniot

Blessed programs have been announced across Pakistan on the occasion of 12th Rabi-ul-Awwal on October 09, 2022 to celebrate the blessed birth of Hazrat Muhammad Khatam un Nabiyeen (p.b.u.h.). Programs are organized all over Pakistan on this auspicious occasion, including gatherings and processions. Processions are held in Rabwah as in other cities across the country.

In the past, in addition to narrating the seerat (way of life) of the Holy Prophet (p.b.u.h.) on this blessed and holy occasion, baseless allegations are made against Jamaat Ahmadiyya regarding our faith and beliefs, and the participants of the procession are incited to make extreme moves against Jamaat Ahmadiyya. # **AHMADIS BEHIND BARS**

Mr. Rohan Ahmad, Malik Usman Ahmad and Hafiz Tariq Shehzad, etc. were booked on May 26, 2020 with FIR Nr. 29/2020 at Police Station FIA Cyber Crimes Wing, Lahore under PPCs 295-B, 298-C, 120-B, 109, 34 R/W, 2016-PECA-11. Pakistan's Cyber Crimes Department of Federal Investigation Agency arrested Mr. Rohan Ahmad.

Malik Usman Ahmad and Hafiz Tariq Shehzad were arrested dated 30.09.3030 on reporting to the FIA office; they are in Camp Jail Lahore.

Syed Ali Abbas, Addl. Sessions Judge Lahore added the blasphemy clause PPC 295-C to the charge sheet on June 29, 2021. Thus, they are now exposed to penalty of death.

The SC rejected their post-arrest bail application. Now the accused filed review petition before Supreme Court of Pakistan.

Mr. Shiraz Ahmad etc. were booked by Cyber Crime Police Station Lahore on June 20, 2019 under FIR Nr. 88, under PPCs 295-A, 298-C, PECA-11, for allegedly creating a group "Sindh Salamat" and allegedly sharing Ahmadiyya content in it. He was arrested from Hafizabad on February 25, 2021. Subsequently the trial court added section 295C of PPC to the said case.

Mr. Abdul Majeed s/o Mr. Abdul Waheed, resident of Shaheen Muslim Town, Taj Chowk, Phandu Road, District Peshawar, aged 20, was accused of blasphemy by a minor named Mr. Imran Ali. The police succumbed to the pressure of the mullas and registered a fabricated case against him under section 295-C of the Pakistan Penal Code, 1860 which carries a sentence of death, on September 10, 2020 with FIR Nr. 648 at police station Phandu, Peshawar. He was arrested on 13.09.2020. He is currently in Peshawar Jail. His trial goes on in the sessions court.

Mr. Zafar Ali and his father Mr. Arshad Pervaiz of Chak 84 Sarshamir, District Faisalabad were booked under PPC 298-C with FIR No. 845 at police station Thekri Wala, District Faisalabad on July 10, 2022 for sacrificing animals on Eidul-Adha. They are in District Jail Faisalabad.

Mr. Saeed Ahmad, Mr. Shakeel Ahmad, Mr. Mukhtar Ahmad, Mr. Imran Ahmad and Mr. Atif Ahmad of Chak 89 GB, Rattan District Faisalabad were booked under PPC 298-C with FIR No. 842 at police station Thekri Wala, District Faisalabad on July 10, 2022 for sacrificing animals on Eidul-Adha. The first-mentioned three Ahmadis were arrested and are in District Jail, Faisalabad.

Malik Zaheer Ahmad was arrested on September 30, 2020 in a fabricated case under Sections 298-C, 295-B, PECA-11 and 109. He was granted bail on February 23, 2021 and was expected to be released in four to five days after paper formalities. On February 27, when Malik Zaheer Ahmad was expected to be released from the Camp Jail, the Cyber Crime Wing Lahore team arrested him under FIR Nr. 88 as outlined in the above case, under PPCs 295-A, 298-C, PECA-11. He was not even formally nominated in the case.

- In 1996, the government of Punjab issued a notification to return all nationalized educational institutions, that affected the community's 8 Schools and 2 colleges which were nationalized in 1972. Despite fulfilling all terms and conditions, and regardless of repeated requests and numerous reminders, the community's institutions are not denationalized.
- The entire population of Rabwah i.e. Ahmadiyya headquarters in Pakistan, was charged under section PPC 298-C on Dec. 15, 1989, and again on June 8, 2008. (Rabwah population is approximately 60,000.)

### **Editorial** Sectarian concerns

A RECENTLY released study by the Brussels-based International Crisis Group has raised some pertinent but disturbing questions about the state of sectarian militancy in Pakistan. In particular, A New Era of Sectarian Violence in Pakistan underscores the troubling prospect of Lashkar-i-Jhangvi cadres, largely dormant at the moment, playing an active role in the malignant activities of the Islamic State-Khorasan chapter, as the local Daesh affiliate is called. Separately, it also examines the role of the Tehreek-i-Labbaik Pakistan in local communal politics and militancy. Though some conclusions of the think tank's report are a tad alarmist, certain aspects send up instant red flags — which the state would be foolish to ianore....

In this respect, there can be little argument with the ICG report's concluding observation that the federal and provincial governments, political parties, the judiciary as well as the military will all "have to play a part in addressing the conditions in which sectarian militants thrive".

THE fact that Afghanistan's Taliban rulers continue to disallow girls from attending secondary school indicates that the hard-line outfit remains wedded to its regressive worldview, despite promises of change. These fears were not unfounded: while younger girls have been allowed to attend school, the older ones have been stopped from attending high school. From Dhamial to Karachi, people are angry and protesting — and the anger is palpable and rising. They are protesting against their marginalisation, their electricity bills, the cost of living, the apathy of the official machinery to the flood victims. From modest living rooms in urban centres to the backwaters of Sindh, a mass of people appears to have had enough. ...

... While the floods may end up thrusting into poverty many of the upwards of 30 million (mostly rural) people affected, food inflation at current levels has been estimated by the Asian Development Bank to impoverish over 25m people. Even after accounting for the overlap, the numbers are staggering.

As in the case of a tsunami, we are being buffeted by the first waves of disaster. Mass migration into cities of the hungry and dispossessed flood-affected people will follow, coupled with food shortages and the attendant second wave of inflation. At the same time, the economy will be groaning under the weight of stabilisation policies, unable to create jobs — or stop joblessness. The perfect storm will only unleash further waves of dis-

It is unlikely that impoverishment and discontent on the scale we will witness will fail to produce over time a tectonic shift in Pakistan's political landscape. Like the fishermen in Hokusai's masterpiece, we can only gape in terrified suspense at the great wave before us.

### **ORDINANCE XX**

FOLLOWING BHUTTO'S LEAD, GENERAL ZIA UL HAQ, THE MILITARY DICTATOR OF PAKISTAN FROM 1977 TO 1988, TRIED TO COURT EXTREMISTS BY PROMULGATING THE NOTORIOUS ANTI-AHMADIYYA ORDINANCE XX IN 1984. THE ORDINANCE ADDED SECTIONS 298-B AND 298-C TO THE PAKISTAN PENAL CODE. THROUGH THIS ORDINANCE, THE RELIGIOUS RIGHTS OF AHMADIS WERE DIRECTLY VIOLATED. UNDER ITS PROVISIONS, AHMADIS COULD BE IMPRISONED FOR THREE YEARS AND FINED AN ARBITRARY AMOUNT FOR ORDINARY EXPRESSION OF THEIR FAITH. ADDITIONALLY, TO PROHIBIT AHMADIS FROM PROSELYTIZING, IT EXPRESSLY FORBADE THEM FROM CERTAIN RELIGIOUS PRACTICES AND THE USAGE OF ISLAMIC TERMINOLOGY. THIS ORDINANCE EFFECTIVELY MAKES A CRIMINAL OUT OF EVERY AHMADI BY INCLUDING THE BROAD PROVISION OF "POSING AS A MUSLIM" A COGNIZABLE OFFENCE, GIVING THE EXTREMISTS À CARTE BLANCHETO TERRORIZE AHMADIS WITH THE BACKING OF THE STATE.
