During the month, a staggering 12 Ahmadiyya mosques were targeted, with some attacks conducted by the police and others by unknown assailants. This escalation in mosque attacks is deeply troubling, particularly as it has pushed the total number of such incidents for the year to 32, more than double the combined count of the preceding two years.

Workplace discrimination against Ahmadis remains a pervasive issue. In September, the names 'Muhammad' and 'Ahmad,' were erased form a law chamber, signalling a disturbing act of prejudice. Teachers identified as Ahmadis encounter similar biases. Additionally, Ahmadi students in a college faced severe opposition from their peers, prompting the principal to contact parents and urge them to withdraw their children for their safety.

Another alarming development is the unbridled freedom afforded to anti-Ahmadi elements to hold rallies and conferences against the peaceful Ahmadiyya Muslim community, complete with hate speech and offensive language. One such large conference was held at the Ahmadiyya headquarters. This tolerance for hate propagators undermines freedom of speech and perpetuates discrimination against Ahmadis, leaving them vulnerable and unheard.

The Pakistani government must take immediate, concrete steps to ensure the rights and safety of Ahmadis. The international community and civil society organizations should add their voices in solidarity, applying diplomatic pressure to uphold the principles of justice, tolerance, and religious freedom.

### **74 AHMADIYYA GRAVESTONES DEMOLISHED BY PUNJAB POLICE**

IHRC has reported several times that a wave of bigotry against Ahmadiyya Muslims has in- madis has ramped up as of late, as the IHRC tensified since the start of 2023.

In a deeply disturbing incident carried out on the night of 22nd September 2023, Pakistan police conspired with radical clerics to destroy 74 gravestones in Daska Kalan, Sialkot.

The tombstones included relatives of Pakistan's first foreign minister Sir Zafruallah Khan who served as the president of the United Nations and the International Court of Justice (ICJ) in the 1960s and 70s. In this way, Pakistani authorities not only disregard their own history but disrespect the living and the dead. Indeed, Ahmadi Muslims and their families are not safe even in death.

The area's Assistant Commissioner and his International Human Rights Committee is- staff led the desecration of the Ahmadiyya graveyard alongside police forces who, acting illegally, cordoned off the nearby streets and taking advantage of the darkness carried out this despicable act.

> They made sure that no Ahmadi was near the graveyard while this act was being carried out. After committing the desecration, the authorities took away the debris. The aftermath can be seen in this online video.

> Unfortunately, the persecution against Ahhas reported almost daily incidents against the minority group. Graveyard vandalism has been a favoured tactic of the Anti-Ahmadi elements in Pakistan for years. This shameful tactic means Ahmadis are not free from persecution even after their death.

> Intolerance and hatred towards Ahmadis in Pakistan is nothing new, rather it has a history spread over decades which is gaining momentum day by day under State supervision. Systematic marginalisation of Ahmadis in all walks of life because of their religious beliefs is not considered condemnable and Ahmadis are being treated as such a class which has no basic human rights.

This must be stopped at all costs and the perpetrators brought to justice immediately. Unfortunately, there is no simple solution as the government and authorities encourage this behavior. They must be discouraged from using cheap tactics to achieve political gain.

IHRC has continuously raised our voice since many months over attacks on Ahmadiyya Muslims places of worship and graves. Attacks on their members have intensified. Most have come to light through social media and International NGOs.

We once again strongly urge the international community to impress upon the Government of Pakistan the need to discharge any absurd cases against Ahmadis and release all held in custody and thus honor its responsibility to provide effective protection and freedom of religious practice to Ahmadis, and ensure that perpetrators of such vicious actions should be brought to justice, to bring its laws and practices in conformity with international standards as ordained by Article 20 and United Nations Universal Declaration of Human Rights Article 2, 18, and 20, and the International Covenant on Civil and Political Rights (ICCPR) Article 25, 26.

Scores of people turned up for a large rally in Daska, Sialkot, on Friday, which had been staged by the politico-religious party Tehreeke-Labbaik Pakistan (TLP) against places of worship of the Ahmadiyya Community.

The place of worship in question was built by Pakistan's first foreign minister and an integral member of the Pakistan Movement, Sir Zafa-

rullah Khan, prior to Partition.

The rally was staged after TLP made a public announcement in this regard on Thursday, posting banners across the city.

Videos posted on social media showed a large rally walking through the city while blaring slogans and naat from their loudspeakers.

While it was unclear whether they had attacked the place of worship, there were reports that an Ahmadi graveyard had been vandalised.

Saleemud Din, a spokesperson for the Jamat Ahmadiyya Pakistan (JAP) in a message said that the district administration and police cordoned off the graveyard and proceeded to demolish the 74 tombstones before loading the debris and broken epitaphs and fleeing.

Earlier, the TLP filed a complaint with the Daska police, demanding action against the administration of the place of worship. The police, however, suggested the party take up the matter with the district administration and the relevant assistant commissioner as the issue fell under their purview.

The TLP, however, directed its followers to take the law into their hands and "decide the

The minarets atop the building in question are barely visible, while there is no signage that identifies it as a mosque or a worship place. It is located adjacent to Sir Zafarullah Khan's ancestral residence in Daska.

Sialkot District Police Officer Hassan Igbal told Dawn that they had increased security around the building and were embroiled in negotiations for a peaceful outcome.

### **POLICE DEMOLISH MINARETS OF AHMADIYYA MOSQUE, DESPITE PROTEST BY LOCALS**







#### Kirto, District Sheikhupura; September, 2023:

ed the police to demolish the minarets and niche of the Ahmadiyya mosque here. Around 50 of local villagers belonging to Ahle Sunnat and Shia community, testified on stamp-paper that people of all religious identities including Ahmadis live peacefully in the village in religious harmony. They added that the Ahmadiyya mosque was built in 1963, long before the anti-Ahmadiyya ordinance of 1984 and they had no objection to the architectural features of the building. The authorities should refrain from demolishing the minarets and niche of the Ahmadiyya mosque and thereby not harm their sentiments, they requested in their application.

On September 20, nine local senior representatives met the RPO and submitted the above-mentioned stamp paper as request. He phoned DPO Sheikhupura and told him that these people would visit him and he should listen carefully to their issues. The above-mentioned representatives then had a meeting with the DPO and informed him of the whole situation. Upon this, the DPO replied that if the locals had no objection, there was no need for any action.

On September 21, around 50-60 miscreants of TLP went to the local elderly and asked him Tehreek e Labbaik Pakistan (TLP) demand- to stop helping Ahmadis. They suggested that it seemed he himself had become an Ahmadi. The old man did not entertain them and replied that they had no religious pact with Ahmadis, except a treaty of peace. This did not satisfy the hate-mongers and they left chanting anti-Ahmadiyya slogans as they passed by the Ahmadiyya mosque. Some decent non-Ahmadis were there to provide security to the mosque. The mob did not stop at this but went to the farmhouse of former Chairman. They tried to convince him to stop supporting Ahmadis. He scolded them and said that he could not do so as these people want to disrupt the peace of the village. He told them to not show up again in the village. The mob left dejected.

> On September 23, the DPO called for the Ahmadiyya delegation and told them that this issue had been highlighted on social media. He further told them that according to the situation, the Ahmadis' non-compliance would start riots all over the country. He said that it was up to Ahmadis whether they wanted to get their whole mosque demolished or just destroy its minarets. He said that one of the above actions has become inevitable. The Ahmadi delegation, shocked on this unjust proposal,

clarified that they are peaceful citizens and the miscreants who were committing such activities to disrupt peace are the ones who had to be stopped. The DPO said that the police was required to act. So, after the evening prayer, a police contingent arrived from Narang Mandi who initially stated that they were only there to provide security. Later around 9:30, some policemen along with the SHO came and destroyed the upper portions of the minarets with sledgehammers and told the Ahmadis to cover the rest.

The TLP left no stone unturned in hatred towards Ahmadis. The police, despite of a writ-

ten statement from the locals, seemed helpless facing the TLP activists and committed this enormity on their behest. This is another incident where the police yielded in front of the unlawful request of religious bigots and failed to provide security to the religious property of its citizens—which is a fundamental right. It has become a routine that the extremists use mobs to threaten the authorities to get their unlawful demands implemented. They aslmost everytime receive compliance. This SOP got going in Imran regime, was followed during the Parvez Elahi time in the Punjab, and is kept in vogue by the 'caretakers'.

### **NICHE AND MINARETS OF THE AHMADIYYA WORSHIP PLACE DEMOLISHED BY POLICE**

#### Shahdhrah town, District Lahore; September 9, 2023:

The police broke the niche and minarets of the Ahmadiyya worship place here.

A group of clerics, accompanied by policemen, came along and demanded demolition of the niche. The police was referred to the recent decision of the Lahore High Court by Ahmadis and told that the High Court has ruled that any alteration in the building of Ahmadiyya worship places built before 1984 is prohibited. This worship place was built back in 1947.

However, the police insisted that the niche will have to be demolished to control the crowd and maintain public order. After some discussion, it was decided to build a wall around the niche to protect it. When laborers were brought in to build the wall, the clerics created a barrier and insisted on breaking the niche. Thereafter the police closed the street from both sides, and with the help of some laborers, demolished the niche and minarets, which were already covered with a wall. A viral video of the incident clearly shows that the police was supervising the operation.







### AHMADIYYA HALL ATTACKED **AGAIN THIS YEAR**

A violent mob broke the minarets, vandalized the Ahmadiyya worship place, and raised inciting slogans against Ahmadis in Saddar area of this provincial capital. A mob stormed an Ahmadi place of worship in Karachi's main business district on Monday afternoon and demolished its minarets.

Armed with hammers, at least four men climbed to the top of the structure where minarets were erected and destroyed them.

Local journalist Arshad Yousafzai said that the Ahmadi place of worship was located just a few streets away from the Preedy Police Sta-September 4, 2023 tion in Saddar, but no police officers could be seen on site.



IHRC has reported several times that a wave of bigotry against Ahmadiyya Muslims has in-



tensified since the start of 2023. In an extremely worrying sign of growing crisis in Pakistan, more than thirty-one (31) Ahmadiyya Mosques have been desecrated in 2023.

On Sep 21st, 2023, in yet another unprovoked and violent episode, a group of extremists attacked an Ahmadiyya Muslim mosque in Karachi.

According to IHRC sources around 12.30 in the afternoon around 15-20 assailants arrived at the Ahmadiyya Muslim Mosque Martin Road and out of them one assailant entered the mosque while using a ladder and he opened the main gate so that the other assail-



ants could enter the premises of the mosque. In this video1 the assailants can be seen entering and attacking the mosque.

Anti-Ahmadiyya campaign has been carrying out here in an organized manner for a yet. long time and there has been a significant increase in these activities for some time now. A case has been registered against unknown persons in Phul Nagar police station, District Kasur under FIR No. 1023 dated 06 September 2023, under The Punjab Prohibition of heinous conspiracy against Muslims. "Qadiani Expressing matters on Walls Act 153-A 2015-2 based on the anti-Ahmadiyya graffiti in Gujjarawali Jhalaar, District Kasur, written on the walls: "Qadiani are infidels, Qadiani first enter

Islam and then enter the shop" and other anti-Ahmadiyya writings. After the registration of case, no one in this context has been arrested

Anti-Ahmadiyya activities have further increased after this case. An inflammatory campaign is being conducted on social media against the concerned police officials as to why they have registered this case. Apart from this, a resolution condemning the registration of the said case has been passed by the Bar Association of Kot Radha Kishan, District Kasur, in which the said FIR has been demanded to be guashed. ### **MINARETS OF AHMADIYYA MOSQUE DEMOLISHED UNDER OFFICIAL SUPERVISION**

Chak Number 183 Murad, District Bahawalpur; September 13, 2023:

TLP activist had filed a complaint with the police in Hasilpur police station against the minarets of Ahmadiyya mosque here. The situation was made tense for over a month. The AC and SHO visited the mosque and the AC called for Ahmadiyya delegation to Hasilpur. He told them to demolish the minarets but the delegation refused to follow these unlawful instructions. The AC and SHO kept on pressurizing Ahmadis to demolish the minarets or

cover them up.

On September 13, 2023, the DSP called for the Ahmadiyya delegation and told them to demolish the minarets. The Ahmadis again refused to comply. Some three to four policemen from Choonawala police check-post came to the Ahmadiyya mosque, entered the premises, switched off the lights and security cameras and closed the roads for any traffic. Meanwhile, two non-Ahmadis climbed to the roof of Ahmadiyya mosque and demolished the minarets in the presence of the police.

The Ahmadis made it clear that police committed this atrocity and Ahmadis were not involved in any such activity nor they will undertake such action. ### **ANTI-AHMADI CONFERENCE IN RABWAH**


#### Rabwah; September 7, 2023:

Later on September 4, Ahmadiyya delegation appeared before the committee formed by DC Kasur under the chairmanship of Assistant Commissioner. He first asked about the worship place case, on which he was told that the matter had been resolved at the behest of DC Kasur.

A member of the committee said that a complaint has been received against Ahmadis that they put up a minaret and took it down when an official visited. Referring to the gravestones, the committee told Ahmadis to take them down. On which they were told that this

cemetery belongs to the Ahmadiyya Jamaat, it is not shared, and according to the decision of the Supreme Court, we have the right to act according to our beliefs within the boundary. The commissioner asked the opposite party to give the names of those who have installed the gravestones, we will register a case against them. On this, the SHO said that the relatives of the deceased persons are not there. The SHO asked the opposite party, "you guys are not from the village, from which place did you come? These people belonged to Bhai Phero and Patuki. The SHO told them that the people you have come on behalf of, have criminal records. They are drug dealers. One is in jail for making a false report. So you guys should not support them"

After this, the DSP said that we will visit the village ourselves. The next day the committee visited the worship place and the cemetery. On this occasion, a member said that the worship place should be visited from inside. On which Ahmadiyya representatives as well as the SHO also said that this is not allowed. On this, the man climbed to the nearby roof and looked. On the next day of the visit, the Ahmadiyya delegation was again called and told to remove the gravestones.

#### **AHMADIS BEHIND BARS**

Mr. Rohan Ahmad, Malik Usman Ahmad and Hafiz Tarig Shehzad, etc. were booked on May 26, 2020, with FIR Nr. 29/2020 at Police Station FIA Cyber Crimes Wing, Lahore under PPCs 295-B, 298-C, 120-B, 109, 34 R/W, 2016-PECA-11, allegedly for sharing a WhatsApp message regarding a religious Quiz program and a General Knowledge competition arranged by the youth organization of the Ahmadiyya community.

Pakistan's Cyber Crimes Department, Lahore which works under Federal Investigation Agency, arrested Mr. Rohan Ahmad.

Malik Usman Ahmad and Hafiz Tariq Shehzad were arrested later on 30.09.2020 on reporting to the FIA office; they are in Camp Jail Lahore.

Addl. Sessions Judge Lahore added the blasphemy clause PPC 295-C to the charge sheet on June 29, 2021, exposing them to the penalty of death.

The Supreme Court rejected their post-arrest bail application. Thereafter the High Court rejected Rohan's bail on statutory grounds on June 8, 2023. The statutory ground here means 'trial not concluded within 2 years of the arrest of the accused'.

Mr. Shiraz Ahmad etc. were booked by Cyber Crime Police Station Lahore on June 20, 2019, under FIR Nr. 88, under PPCs 295-A, 298-C, PECA-11, for allegedly creating a group "Sindh Salamat" and sharing Ahmadiyya content in it. He was arrested from Hafizabad on February 25, 2021. Subsequently, the trial court added the Blasphemy section 295-C of PPC to the said case.

His bail plea was rejected by the Supreme Court.

Malik Zaheer Ahmad was arrested on September 30, 2020, in a fabricated case under Sections 295-B, 298-C, PECA-11, and 109. He was granted bail on February 23, 2021, and was expected to be released in four to five days after the paper formalities. On February 27, when Malik Zaheer Ahmad was expected to be released from the Camp Jail, the Cyber Crime Wing Lahore team arrested him under FIR Nr. 88 as outlined in the above case, under PPCs 295-A, 298-C, and PECA-11. He was not even formally nominated in the case.

His bail plea was rejected by the Supreme Court. His bail on statutory ground is pending before Aditional Session Lahore Mr Nawaz Bhati,

Mr. Mubarak Ahmad Sani Principal of was arrested on January 7, 2023, from his home in Rabwah. He was booked with FIR Nr. 661/22 under the blasphemy section 295-B, PPC 298-C, and the Punjab Holy Quran (Printing and Recording) Act 2011, allegedly for printing, publitioning and distributing copies of the Holy Quran as a prize among students who memorized the Holy Quran. He was sent to Jhang Jail after judicial remand and later transferred to District Jail Faisalabad. His bail plea was rejected by Additional Sessions Judge Lalian, District Chiniot.

The police booked Syed Ali Ahmad Tariq for having 'Syed' in his name, under PPC the anti-Ahmadiyya 298-B with FIR No. 54 on April 27, 2023, in the police station City Court Karachi. He was arrested and sent to jail.

Sindh High Court allowed his release on bail on May 27, 2023, but due to a production order in an old case of October 20, 1992, his release has been stalled.

On 14.07.2023 the Government of Sindh allowed for an inside jail trial of his cases (under FIR No: 54/23 and 121/92) concerning Mr. Syed Ali Ahmad Tariq at Central Prison & C.F Karachi by the concerned notified sitting Judge(s).

An application for his release stating that his detention is illegal has been filed before the trial Court in Karachi, Pakistan. The proceedings of the said Application are currently underway.

Mr. Javed Iqbal and Mr. Aftab Talib of Chak 433 GB, District Toba Tek Singh were booked and arrested under PPC 298-C with FIR No. 508 at police station Gojra Saddar, District Toba Tek Singh on June 30, 2023, for sacrificing animals on Eid-ul-Adha. The Lahore High court granted them bail on 5th of September 2023

Mr. Asad Ijaz and Mr. Ahmad Shiraz of Chak 433 GB, District Toba Tek Singh were booked and arrested under PPC 298-C with FIR No. 509 at police station Gojra Saddar, District Toba Tek Singh on June 30, 2023, for sacrificing animals on Eid-ul-Adha. The Lahore High court granted them bail on 5th of September 2023

Mr. Mubashar Ahmad including four others from Nagar Parkar, District Tharparkar was booked in a police case on December 27, 2022, in Nagar Parkar police station under PPCs 337 (iv), 337A (i), 334, 337F(i), 337L (ii), 147, 148, 149, 504 with FIR No. 59. On January 10, 2023, Additional Sessions Judge Mithi, District Tharparkar rejected Mubashar's plea for bail confirmation. An appeal was filed against this decision in Sindh High Court where they rejected his bail request. An appeal was then filed in the Karachi Registry of the Supreme Court which also rejected his bail on June 30, 2023. On July 7, 2023, he presented himself before the Sessions Court where the police took him into custody and sent him to prison. The Sindh High Accepted his appeal and reduced his sentenced to "already stayed in prison" and after paying the daman amount (a form of fine) of Rs 40,000/- Mr. Mubashar was released in September.

#### **IMPRISONMENTS - AS OF SEP 30, 2023:**

- Mr. Mubarak Ahmad Sani principal Hifz School Rabwah was arrested in Jan.
- Mr. Syed Ali Ahmad Tariq advocate Supreme Court of Pakistan arrested in
- 19 Ahmadis are behind bars solely on account of their faith.
- Fabricated cases against 8 Ahmadis were registered during Nov and an FIR is registered against some members of Ahmadiyya leadership in Pakistan in Dec.
- A 20-year-old Ahmadi student has been awarded 5 years imprisonment in Nov 2022, for hurting the religious feelings.
- 13 Ahmadis were arrested last year for sacrificing animals on Eid. This year 26 Ahmadis were nominated in 6 cases and 7 were arrested on Eid festival.
- A 65 year old Ahmadi lady and another Ahmadi were arrested under blasphemy clauses during February for allegedly tearing off an anti-Ahmadiyya poster. She was released on bail. Her trial continues.
- 2 Ahmadi prisoners died while in police custody (Feb. 2021 & Jan 2022.)

# **Alarming Facts SINCE JANUARY 2021**

- 6 Ahmadis have been murdered for faith, raising the total to 276 since the promulgation of Ordinance XX
- 19 murder attempts, 10 attacks during 2022, 2 attacks in May.
- 55 new cases have been registered against Ahmadis under the blasphemy laws & Anti-Ahmadi laws.
- 21 Ahmadis are arrested during 2023 in different religion based cases. 108 Ahmadis were booked in 2022 and 110 Ahmadis were booked in different religious base cases.
- 32 mosques were targeted and desecrated during 2023. This figure was 14 last year, 14 in 2021, and 7 in 2020.
- 10 Ahmadis arrested during August. Previously 26 Ahmadis are nominated in cases for sacrificing animals on Eid festival, 7 of them are arrested.
- 2 Ahmadi prisoners died in custody, they were imprisoned for their faith.
- 29 Ahmadiyya mosques desecrated, 1 mosque sealed by the authorities. 9 attacked during 2023
- 418 graves have been desecrated, 197 of these were during 2022. 93 during 2023 so far. Burial of an Ahmadi lady denied and the graveyard sealed in Nov 2022. Burial of three Ahmadis denied in 2023.
- Sacred inscription from 22 houses and shops have been removed.

#### **AHMADI CENSORSHIP**

- The Pakistan Telecommunication Authority (PTA) has blocked 20 non-Pakistan based foreign websites affiliated with the worldwide community and properly registered in their respective countries. PTA has also issued notices to their operators with criminal prosecution for violating Pakistan's blasphemy and anti-Ahmadiyya laws. According to PTA any website that portrays Ahmadis as Muslims will be blocked in
- Pakistan Electronic Media Regulatory Authority (PEMRA) has ordered that Ahmadi channels (MTA) should not be carried by any distribution service licensee.
- In 1996, the government of Punjab issued a notification to return all nationalized educational institutions, that affected the community's 8 Schools and 2 colleges which were nationalized in 1972. Despite fulfilling all terms and conditions, and regardless of repeated requests and numerous reminders, the community's institutions are not denationalized.
- The entire population of Rabwah i.e. Ahmadiyya headquarters in Pakistan, was charged under section PPC 298-C on Dec. 15, 1989, and again on June 8, 2008. (Rabwah population is approximately 60,000.)
- The government has banned all outdoor rallies & conferences of Ahmadis in Rabwah.
- The government of Punjab has banned the publishing of the Quran and its translation
- The government of Punjab has banned the entire written works of the Founder of Ahmadiyyat.
- · Ahmadiyya daily newspaper and periodicals for women, youth, children and elders were banned by a Punjab government notification.
- Authorities have prohibited sports events organized at a community level.

#### **DECLARING AHMADIS AS NON-MUSLIMS**

THE PAKISTANI RELIGIOUS ESTABLISHMENT BRANDS THE AHMADIYYA COMMUNITY HERETICAL IN NATURE AND DOES NOT APPROVE OF ITS REFORMATORY NATURE. POLITICIANS HAVE ALSO FOUND IT EXPEDIENT TO SUPPORT THE RELIGIOUS ESTABLISHMENT IN THEIR ANTI-AHMADIYYA STANCE. THE FIRST COUNTRYWIDE WAVE OF VIOLENCE AGAINST THE COMMUNITY ERUPTED IN 1953. FOLLOWING THE EXTENSIVE RIOTS, AN IN-DEPTH JUDICIAL INQUIRY BY THE CHIEF JUSTICE AND A JUDGE OF LAHORE HIGH COURT FOUND POLITICS TO BE THE MAIN CAUSE OF DISTURBANCES. MANY YEARS LATER, IN 1974, MR ZULFIKAR ALI BHUTTO, THE THEN PRIME MINISTER OF PAKISTAN, FOUND IT POLITICALLY ADVANTAGEOUS TO HAVE AHMADIS DECLARED A NON-MUSLIM MINORITY, WHICH IN PAKISTAN IS A FORM OF SECOND RATE CITIZENSHIP. IT WAS A UNIQUE INNOVATION; WHILE OTHER NON-MUSLIM RELIGIOUS GROUPS, LIKE CHRISTIANS AND HINDUS, WERE NON-MUSLIM MINORITY BY THEIR PROFESSION, AHMADIS WERE FORCIBLY DECLARED A NON-MUSLIM MINORITY THROUGH LEGISLATION.

#### **ORDINANCE XX**

FOLLOWING BHUTTO'S LEAD, GENERAL ZIA UL HAQ, THE MILITARY DICTATOR OF PAKISTAN FROM 1977 TO 1988, TRIED TO COURT EXTREMISTS BY PROMULGATING THE NOTORIOUS ANTI-AHMADIYYA ORDINANCE XX IN 1984. THE ORDINANCE ADDED SECTIONS 298-B AND 298-C TO THE PAKISTAN PENAL CODE. THROUGH THIS ORDINANCE, THE RELIGIOUS RIGHTS OF AHMADIS WERE DIRECTLY VIOLATED. UNDER ITS PROVISIONS, AHMADIS COULD BE IMPRISONED FOR THREE YEARS AND FINED AN ARBITRARY AMOUNT FOR ORDINARY EXPRESSION OF THEIR FAITH. ADDITIONALLY, TO PROHIBIT AHMADIS FROM PROSELYTIZING, IT EXPRESSLY FORBADE THEM FROM CERTAIN RELIGIOUS PRACTICES AND THE USAGE OF ISLAMIC TERMINOLOGY. THIS ORDINANCE EFFECTIVELY MAKES A CRIMINAL OUT OF EVERY AHMADI BY INCLUDING THE BROAD PROVISION OF "POSING AS A MUSLIM" A COGNIZABLE OFFENCE, GIVING THE EXTREMISTS À CARTE BLANCHETO TERRORIZE AHMADIS WITH THE BACKING OF THE STATE.
