## ORDER

WHEREAS, the District Police Officer, Chakwal, vide letter No. 16429-30/S dated 10.06.2024 has reported that as per report of SHO PS Choa Saidan Shah duly forwarded by DSP/SDPO Choa Saidan Shah, Tahir Ahmed S/o Rasheed Ahmed R/o Dulmial, Tehsil Choa Saidan Shah, district Chakwal may cause deterioration for Law & Order situation in the area and requested for issuance of his detention order u/s 3(1) of the MPO, 1960, for a period of 30 days to ensure peace and tranquillity in district.

- 2. AND WHEREAS, under the above circumstances, the District Police Officer, Chakwal has requested that in order to prevent the said miscreant from his unlawful activities and acting in a manner prejudicial to the public safety or the maintenance of the public order, he may be detained u/s 3(1) of the MPO, 1960 for a period of 30 days.
- 3. AND WHEREAS, the matter was discussed in District Intelligence Committee meeting held on 10-06-2024. The Committee unanimously recommended that in order to prevent the society from his activities, which are quite detrimental to public peace and tranquility, sectarian harmony, as well as law and order situation, it is very necessary that he may be detained under section 3(1) of the MPO, 1960.
- 4. WHEREAS, Considering the above said grounds given by the District Police Officer, Chakwal and evidence of his conduct being prejudicial to public peace as depicted in the report of the District Police Officer, Chakwal, I am fully satisfied that in order to prevent the said person from acting in any manner prejudicial to public safety or the maintenance of public order, his detention is necessary and expedient in public interest.
- 5. NOW THEREFORE, I, Qurat-ul-Ain Malik, Deputy Commissioner, Chakwal, in exercise of the powers conferred upon me u/s 3(1) of the Punjab Maintenance of Public Order Ordinance, 1960, vide Home department's Notification No. SO (Judl-III)2-1/2017 dated: 20th July, 2017, hereby order to detain Tahir Ahmed S/o Rasheed Ahmed R/o Dulmial, Tehsil Choa Saidan Shah, district Chakwal, for a period of 30 days from the date of his entrance in District Jail, Jhelum to avoid any likelihood of breach of peace/unlawful assembly in the district.

6. The detainee is at liberty to make representation to Government of the Punjab against said order.
